The fees include transportation from Haledon Public Schools. A one month non-refundable deposit is due upon registration and will cover the first month your child attends our program. Fees are charged on a calendar month basis. The Club will be open for all ASP members from 7:30-6pm at no charge for all scheduled days off. A daily fee of \$10 per day will be charged for any child not currently enrolled in the ASP that would like to attend a non school day at the Club.



Please note: The After School Program follows the Haledon public school calendar. We will provide transportation on all scheduled early dismissal days. We will NOT pick up on early dismissal days due to inclement weather.
